
Selectperson Labreck – Trafton is going well, was full for the 4<sup>th</sup> with some on the lawn.

This would be an agreement with Aroostook County to share the cost, with the county and 22 other towns.


Selectperson Pelletier moved to sign ARPA Program; seconded by Selectperson Durepo, II. **Motion Passed 5 to 0.**

## 13. Executive session if needed


