Bill Dobbins informed the Board that the main reason for the Solar Project is a financial one to save the school and ultimately the Town money. The project is a two-part project and the parts are as follows:

1. Credit System – allows them to purchase units within the system. This could save the Town approx. 85% this could be an estimated savings of \$ 7000 to \$ 8000 a year.
2. Land lease - \$ 1000.00 per acre per year. The total acreage for this project is 16 acres.

Mr. Dobbins also informed the Board that the state will not extend its waiver for the lack of Audit. This means the state subsidy will stop at the end of November and that would add approximately \$ 136,000 dollars.
